Presidents Report

The 2022 season has been a great success for the Association having made significant change in 2021 to Affiliate with Hockey ACT under the shadow of Covid19. While Covid's presence has faded it remains not far from our collective minds. The completion of 20 rounds of winter competition is a welcome achievement and I thank the clubs, the Board and Cayte for making the commitment to engage with our members and resume play. The feedback is that this season has been a positive one with tolerance and understanding. The engagement in Division 1 men with clubs allowing Wombats to call on other clubs for assistance has been greatly appreciated. The on-field game spirit of fair play and the need to follow the good sport code has been appreciated.

The support of the Albury City Council, Federal and State Governments during the worst of Covid has made a significant difference to our position over the last two years and we end 2022 in a good financial position.

The commitment of HACT to the Participation Officer position has been significant and is a stepping stone toward ensuring Hockey Albury Wodonga has a sustainable and prosperous future. The vibe around the HookIn2Hockey, Stick2Hockey/U10's competition is an exciting development and one which I am sure that clubs will embrace to ensure we are future proof.

This is my 11th Presidents report over two terms as President and in my opinion the Association while having challenges is in good shape financially with our capable Operations Manager Cayte ensuring the 2023 season and beyond has an exciting future. Attraction and Retention of skilled and unskilled volunteers remains a challenge. Covid has allowed many in the community to reassess their financial as well as their time commitment and priorities. Hockey as with many sports is being challenged for relevance and it is my view there has never been a greater need for the Hockey "Village" to grow, providing a place to belong, share experiences, learn and have fun. Government is funding many programs including mental health initiatives, domestic violence response, racial tolerance and understanding. Sports such as Hockey has been a conduit for providing connection, tolerance and understanding on the back of a substantial volunteer base with limited resources for many years.

HAW was fortunate in receiving government support with ATO cash booster, job keeper, NSW border business boost and NSW sports grants which assisted cash flow and defrayed overhead costs over the last two years.

The Commercial club assistance through their sponsorship of our Junior development has been an effective partnership enabling defraying of costs of junior development, Academy costs and Coach reimbursement.

The Director positions of Finance & Facilities, Carnival & Events, Marketing, Promotion & Media portfolio positions not being filled over the last two years creates more work for others and often work that needs to be done cannot be delivered. The assistance of Narelle, this year's MAC award recipient, has made a big difference in connecting with our community. The Association will, if the above positions are not filled, need to outsource the above responsibilities to ensure we can operate at a reasonable level of efficiency and respond to our Hockey community needs.

The continued support of HACT with the Spitfires over the last eight years continues to be valued and appreciated. Spitfire team sponsorship by Xypex, the Astor and Hertz in 2022 is acknowledged and we a grateful for their ongoing support. The Capital League competition is a significant pathway for elite players to the AHL and potential national representation. The support of the Scots School by providing

employment for Pippa and Justine has given the Capital league womens side and the local Division 1 Women's competition a new dimension and appeal.

The work of Cayte is appreciated greatly in the administration and oversight of our sport in the region has been again well organised with the Board members supported many, so that hockey is an enjoyable experience for all participants. I am very grateful for the hard work by many at Board, Club and Community level, building the game of Hockey as a sport of choice.

The completion of the club room and change room development at the Wodonga Hockey Centre is a great outcome and well done to the Wodonga Hockey Club for the pursuit of partnership funding.

The capable management of finances by Michael Darmody, Cayte Campbell and Rod Bramich is appreciated highly by the Board. The reserves have been maintained and it is recommended that fees will increase by 2% in 2023 after three years of no increase. The design process for a new pavilion and change rooms at Albury is well under way with a steering party appointed to work on a new change room and club house design with \$200,000 of funding from Albury City to complete the concept design, detailed plans and necessary documentation. This will improve player and spectator accommodation and ability for connection off the field.

To those who support our Board and their committees, I thank you, as your efforts are greatly appreciated and a very important part of our community. I thank the club's members who assisted Matt from Marshane Media who look after our scoreboards, Hamblin Hire, Deb Hodgkin in the canteen, Jane Verbunt, Chelsi Russell, Josh Roy, Julie Versteegen, Paul Gow, Matt Bardy Laddie Bardy, Andrew McMillan and Dennis Martin for assisting with ground maintenance. The important role, of investigation and Tribunal is overseen by David Nancarrow, Chris Baine and Dennis Martin, which is appreciated.

We have commenced a strategic Planning process and met with a number of clubs to discuss pathways and in particular the need for attraction and retention of juniors. Each club is expected to provide resources to assist Glenn Delaney in the role of Participation officer to engage in the promotion and delivery of recruitment initiatives.

In conclusion, on behalf of the Hockey community I thank my fellow Board members - Deb Lawrence, Doug Agar, Josh Mason, Kylie Heagney and Sherren Rahaley and their sub committees with Cayte who have been assisted by many to manage the Association on behalf of club's supporters and families in 2022

Competitions

I start by thanking all current board members for their continued support in regard to competitions and being active sounding boards when situations arise. Thank you to Jo Duffy for her continued work with the permits committee, this really has become a streamlined process and your years of service to permits is not taken for granted.

Season 2022 after a trying 2020 and 2021 finally saw a full season completed, 794 games were scheduled over a total of 21 rounds. With number of rounds for each division or age group below.

- Division 1 and 2 played 20 rounds plus finals
- Division 3 21 rounds plus finals

In juniors we saw the following, despite the breaks:

- Under 17s played 17 rounds plus finals
- Under14s played 18 rounds plus finals
- Under 12s played 19 rounds plus finals

Thank you to our participation officer Glenn Delaney on a successful Under 10s program, hopefully continued growth will see all clubs benefit from this offering.

I thank all clubs for their participation, and flexibility when changes were required. There is always some tweaking required throughout the season due to various issues that arise outside of our control.

It was great to see despite clubs varied sizes and team numbers, that all clubs were present in the first week of finals, with grand final weekend seeing 7 clubs still vying for at least 1 premiership.

Finals series faced some challenges with weather wreaking havoc on 2 weekends seeing u17s being rescheduled to a Saturday afternoon and evening, and then a delay to the grand final program again on a Friday night.

By now we are aware of Hockey Australia's move in junior age groups from the start of 2024 and as an association will offer what we can based on demands and needs of junior players, in the coming years.

Currently we see continued support from the hockey community in the embracement of a twilight programs with 16 teams in the open program on Tuesday nights and 5 teams on the Thursday night junior program which is a first for this year. I thank Cayte Campbell for her support in getting both these programs up and running.

Season 2023 Hockey Albury Wodonga will continue to evolve with the goal of improving the hockey experience for all our players.

Draft Calendars for season 2023 have been distributed to clubs for feedback prior to the 1st of December.

Lastly congratulations to all our 2022 premiership teams. The positive conduct of the hockey community throughout the finals series topped off a great season that finally felt normal again.

Development

First of all, I would like to thank the Board, clubs, players, and community of Hockey Albury-Wodonga for their hard work and positive efforts during the first "normal" year of hockey in a while.

This year's moving across to Hockey ACT and the introduction of the Participation Officer role has been a positive change, and while there are undoubtedly tweaks to be made going forward, this offers the potential to have a strong influence on the number of people playing our sport going forward.

Our partnership with The Scots School Albury allowed us to bring two overseas players for our senior Spitfires, Justine Van Latham (from Belgium) and Pippa Best (from Ireland), and they added greatly to our coaching offering, presenting Tomahawk clinics to a number of clubs, as well as International Academy sessions to individual players and groups at U12 and U14, and U15 and U18 levels.

Part of this change was rebranding our TigerMoths programme to the nationally recognised Stick2Hockey brand. Numbers were quite good in this space, and players and parents seemed to enjoy this offering, as well as our ongoing HookIn2Hockey programme. Successful programmes were also run in Wodonga, Corowa, and Wangaratta. This goes hand in hand with the Schools Roadshow, which is an area which we will continue to focus on going forward. The division of the area around Albury Wodonga into specific club zones is a positive one, and we will prioritise making this work in the best way for all parties going into 2023.

We await the Hockey Australia Hockey Ed program to assist building capacity and capability of our skilled volunteers.

Our HAW Spitfires Academy again attracted good numbers in early 2022 under Dom Wilde as Head Coach. At time of writing we are in the process of finalising details for this year's offering based on athlete, parent, and coach feedback. We have also continued our affiliation with Southern Sports Academy, allowing our older Juniors to gain experience within the New South Wales Academy system. A number of players attended this year's Academy Games in Wagga Wagga; next year's games will be held in the same venue.

Overall, I look forward to the opportunities which we will be able to offer in the Development space in 2023, and hope to assist our players, coaches, and officials to grow and develop in their love of the sport.

Our presence on Facebook this year has been continued to increase with consistent marketing on social media including such things as "Throwback Thursday". We intend to continue to increase our presence going forward. Particular thanks to Narelle Hamilton for her work in this area.

Also thanks to Narelle for her work with the weekly Sunday night reports to the media on the Division One games. The Border Mail weekend reports and photos and the junior page are all the result of her hard work. Our coverage by Prime TV which uses the reports has been enhanced by the streaming footage each week. We will be working with the media outlets to improve this next year.

Finance and Facilities

The Financial report for 2022 for the 12 months ending 30 September 2022 is a remarkable achievement reflecting on our clubs commitment to remain engaged with their players and supporters. We had 79 teams including 36 Junior teams competing in the winter competition. This followed two years of Covid.

The estimated revenue for a team ranges from \$1,500 to about \$4,000 and is based on variables including location and number of games etc. Fees for games and affiliation have not increased since 2019 and we are fortunate that given HAW incorporated structure, we were eligible for government assistance which assisted us maintaining viability. It did however result in no provisioning for Capital works in 2020 and 2021.

This year excluding depreciation, we made a profit of \$ 115,950. After deducting the depreciation allowance of \$143,174 we made a loss of \$27,224.

Our net current assets have increased from \$277,524 to \$403,449, a pleasing result.

We have been fortunate in containing operational costs, maintenance, and the extended life of Ground 2 turf replacement at Albury which has a significant effect on cash flow and reserves.

The canteen traded successfully and provided additional catering for athletics and some school days. The canteen under Deb Hodgkin had a surplus of \$8,699 and well done to the team.

The strategy is for the revenue from affiliation, competitions and training is about 60% of revenue which is to cover depreciation ground expenses and operational overheads. The financial aim of Representative, Development, canteen and Events aim is to break even.

The sponsorship from Xypex for Spitfires and Commercial Club for junior development plus signage income assists with offsetting costs of our activities. A further saving is with the many favours asked and fulfilled by volunteers.

The increase in costs of affiliation to HACT has largely been accepted. The support of HACT in the Participation Officer role and recruitment and retention programs is greatly appreciated and I trust the clubs will continue to embrace this initiative and continue to build on our junior player registrations particularly in the Stick2Hockey/U10's program.

Thank you to Michael Darmody and Rod Bramich in the absence of a Director of Finance.

Albury City continues to support the Association and the funding of \$200,000 for the design process for a new pavilion and change rooms at Albury and is greatly appreciated. Grants this year tallied \$9,975 which included Job Saver

The Board has recommended up to \$25,000 be allocated to contributing to the junior recruitment and retention initiative, assisting clubs with capacity and capability building and capital works.

The Board has recommended a 2% increase on Affiliation and Ground Hire costs for 2023.

Notes to the Financial Reports

1. Statement of Significant Accounting Policies

The significant accounting policies which have been adopted in the preparation of these financial statements are:

(a) Basis of Preparation

The financial report is a special purpose financial report which has been prepared in accordance with the Accounting Standards, Urgent Issues Group Consensus Views, other authoritative pronouncements of the Australian Accounting Standards Board and the Associations Incorporations Act 209 of (NSW) and the Associations Incorporation Reform Act 2012 of (VIC).

They have been prepared on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. The accounting policies have been consistently applied.

(b) Depreciation / Amortisation of Property, Plant and Equipment

Items of property, plant and equipment including leasehold improvements are depreciated/amortised over their estimated useful lives from the date of acquisition using the straight –line method at rates ranging between 5% and 50%.

(c) Inventory

Inventories are carried at the lower of cost and net realizable value. Cost is based on the first in, first out principle.

(d) Income Tax

The income tax laws exempt sporting clubs from the liability of income tax.

(e) Goods and Services Tax

Revenues, expenses and assets recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognized as part of the cost of the asset or as part of an item of the expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the Statement of Financial Position.

Cash Flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.
