### 3. President & Board Reports

Bert welcomed all members including Eva Medcraft and Rob Sheekey.

Bert mentioned that this will be his final Presidents report after 10 years in the role.

In 2013 Spitfires moved to ACT, we had 1500 member, \$450k turnover and a debt of \$250k, and net assets of \$100k. Today we sit at 1162 members, turnover of \$400k, but no debt. In that time two fields have been replaced.

The President and Directors gave their reports (these are included in the Annual report). No questions were asked of the reports.

Bert Eastoe presented the 2022 Financial report with Profit & Loss & Balance sheet.

Points of note further to the report include

- HAW has slightly bettered the number of teams in the competition this year, which is in contrast to the national trend.
- Carry forward amounts include \$11,000 (the Wodonga Practise Pitch) & \$2,000 from EnviroCulture for capital works.
- Canteen has made a profit of \$8k
- Capital works plan moving forward will include an upgraded clubhouse/changerooms at Albury, new lights at Wodonga, scoreboard at Wodonga and new dugouts at Wodonga.
- The Board has recommended that an amount of \$25k be used moving forward to assist with recruitment and retention.

#### 4. **General Business:**

4.1 Constitution Review.

Many locals clubs have reviewed their constitution and should look to upgrade to the new model constitution. Currently members can join through RevSport without begin endorsed by the club which needs to be addressed

4.2 Acknowledging service.

HACT master recognises contribution each year. We have the MAC award and Life members but we have acknowledged no life members since 2013. We need a standard for recognition. We will be getting a committee to address.

4.3 Capital Works

Discussion on the Albury clubhouse and where the money is coming from and what it will be used for in this first phase. The money will be used for concept and detailed design so we are shovel ready. At this stage our contribution is looking to be \$250k and we will also be paying



for half of the replacement of AHC1. Wayne has done modelling that says we are capable of putting in \$250k & borrowing \$250k

### 4.4 Strategic Plan

Commenced the process to get our own strategic plan referencing the HA & HACT strategic plans recognising that we should align with that but have local nuances. One thing we must work for and with is our skilled volunteers.

We plan to convene a SGM in March or April to revisit these four issues and hopefully resolve a number of them.

# 5. Appointments

Bill Russell is the Public Officer for the Association and is honoured to continue in that role.

#### 6. Schedule of Fees

Wayne Nagle from Falcons has assisted with the budget (see annexure A) and this leads on to the Affiliation and Game fees. The proposed 2023 Schedule of Fees has a 2% rise this year in line with the increases pre Covid.

Discussion on monies that needs to be go back to the clubs to assist with training of skilled volunteers.

Clubs requested that umpires fees need to be finalised for clubs to set their budgets.
